

Contest Rules:

NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT INCREASE THE CHANCES OF WINNING.

1. Eligibility: This Campaign is open only to those who sign up for the Nesters Market email list here <https://nestersmarket.com/eflyer-referral-signup>. Current Nesters Market email subscribers can enter by referring a friend or colleague and who are 18 as of the date of entry. The Campaign is only open to legal residents of British Columbia, Alberta, Saskatchewan and is void where prohibited by law. Employees of Nesters Market, its affiliates, subsidiaries, advertising and promotion agencies, and suppliers, (collectively the "Employees"), and immediate family members and/or those living in the same household of Employees are not eligible to participate in the Campaign. Current subscribers of the Nesters Market Email list can enter by referring a friend or colleague to gain entry. When you submit referrals, it counts as 1 entry into the contest. You gain bonus entries for every one of your referrals that subscribes to our email list. Example: if you submit 5 referrals, you get 1 entry into the contest. If 2 of your referrals subscribe to our email list, you will receive 2 bonus entries. The entry must fulfill all Campaign requirements, as specified, to be eligible to win a prize. Entries that are incomplete or do not adhere to the rules or specifications may be disqualified at the sole discretion of Nesters Market. You must provide the information requested.
